

# THE SILENT TRANSFORMATION OF GOVERNMENTAL AUTHORITIES AND PUBLIC OFFICES INTO PRIVATE CORPORATIONS

Our society is so “specialised” nowadays, that nobody even knows what his own neighbour is doing anymore. Everyone depends on the work of third parties. And it's no different in politics. People only do what the government, state authorities and political parties tell them to – because they don't understand politics.

## **NO ONE HAS EVEN NOTICED THE TRANSFORMATION OF PUBLIC INSTITUTIONS INTO PRIVATE COMPANIES**

That's why, ever since the Swiss Federal Railways and Postal Telegraph and Telephone agency became listed companies and civil servant status was revoked, hardly anybody has noticed that the confederation, cantons, cities and municipalities, as well as their administrations, have transformed from institutions under public law into joint-stock corporations and private companies entered in the commercial register.

## **THIS PRIVATISATION PROCESS IS TAKING PLACE IN SECRET**

This privatisation process is going on behind the scenes, which is why these entries are not made public in the commercial register. Some of this information is published in private business databases. This confirms that there is a process underway. Research<sup>1</sup> indicates that this process is already approx. 80-90% complete.

Lecture notes by a law firm from 2004 confirm research pointing to a clandestine form of privatisation being carried out.<sup>2</sup>

## **THE SWISS CONFEDERATION HAS ITS HEADQUARTERS IN BELGIUM**

In 2014, the Swiss Confederation was “incorporated”, i.e. registered [as a corporate entity] and established its headquarters somewhere in Belgium. On 12 July 2006, the Swiss Federal Administration was entered in the commercial register (“incorporated”) and has been run as the parent company ever since.

## **ALL OF SWITZERLAND IS STRUCTURED LIKE A HOLDING COMPANY**

The cantons were all “incorporated” on different dates, only some of which are known. Taking the canton of Zürich as an example, it can be seen that all of the directorates are run as the parent company (i.e. as joint-stock corporations), since some of the offices below them are referred to as PLCs or subsidiaries. On the whole, it must be noted that all of Switzerland is structured like a holding company.

Whoever thinks that privatisation is an illusion is kidding himself, since this process is in full swing all over the world. This is why former SPD chairman and subsequent vice chancellor Sigmar Gabriel made the following remark on 5 March 2010:

*“I’m telling all of you, we don’t have a federal government at all. Mrs. Merkel is the managing director of a new non-governmental organisation in Germany.”*

## **THE TRANSFORMATION TOOK PLACE WITHOUT LEGAL LEGITIMATION**

For a company to be entered in the commercial register, the decisions of the chief management bodies must be submitted in writing. With an organisation under public law, these would

be decisions of the parliament and of the people. But neither one of them exists, which makes these establishments illegal and thus means that these companies also lack public legitimation.

## **ALL EXECUTIVES AND EMPLOYEES OF THESE COMPANIES ACT AT THEIR OWN RISK**

In order for a commercial enterprise to act with legal validity, it must also be published in the Swiss Official Gazette of Commerce (SOGC). If this is not done, the company is not allowed to operate. Ad-missions and departures of executives in the company must also be published in the Official Gazette just the same way. If this is not published, then not only these executives, but all employees of the company in question are acting at their own risk and therefore assume private liability for all actions and omissions. Every managing director must know this.

## **BECAUSE OF THIS LACK OF LEGITIMACY, ALL ACTIONS OF THESE EMPLOYEES ARE NULL AND VOID**

Since all of Switzerland has been a nested holding company since 2014 at the latest, it follows that all actions of these former public authorities and offices – which are now private companies – are null and void, since they have no legitimacy to operate under commercial and public law.

## **THE IDEOLOGY OF PUBLIC AUTHORITIES AND OFFICES AS COMPANIES IS PART OF THE IDEOLOGY OF GLOBALISATION**

The ideology of public authorities and offices<sup>3</sup> as companies is part of the ideology of globalisation. The fourth industrial revolution that is currently underway (aka Industry 4.0) is also part of this and is supported by the transformation of public au-thorities and offices into private companies. This is part of the initiative known as “The Great Reset.”<sup>4</sup>

Klaus Martin Schwab, founder of the World Economic Forum and author of The Fourth Industrial Revolution describes in his book the changes to take place by the year 2030, including:

*“You’ll own nothing and be happy”*

This is nothing less than the implementation of the Communist Manifesto: the abolition of private property, freedom, justice and much more.<sup>5</sup>

The only way to understand all of this is to know the true history<sup>6</sup> we weren’t allowed to learn in school – for he who controls the past controls the future as well! Hence the famous quote of Franklin D. Roosevelt (1882-1945), 32<sup>nd</sup> President of the USA:

*“In politics, nothing happens by accident. If it happens, you can bet it was planned that way!”*

It’s time to wake up and start taking your destiny at least a little bit into your own hands, for the intentions behind the fourth industrial revolution are nothing less than a part of the third global revolution which kicked off early last year and has had a firm grip on the whole world grip ever since.

It’s not without reason that sociologist Theodor W. Adorno, a central figure of the Frankfurt School, said<sup>7</sup>:
