Public authorities and offices as companies  
Legitimacy and its consequences

---

Dear Sir or Madame,

You may be surprised to receive a letter from someone who is not a resident of your canton. My story begins in the town of Flawil in the canton of St. Gallen, but that is not why I am writing you. The reason is that this matter is essentially the same all over the world. It is not a personal problem, but one that concerns everybody – only some have never noticed it, and others have not delved into it deeply enough to find out about the actual reasons for it.

Some have noticed that the history we learn in school is not accurate, while others have noticed that theories in physics are not able to explain certain phenomena or the results of a particular experiment.<sup>1</sup> One could add to the list as long as one pleases, since there is a system to it all – but getting to the bottom of it is no simple matter.

At any rate, as a result of having been impacted by the widespread criminality in public offices<sup>2</sup> (of municipalities, cantonal administrations, governments, parliaments and courts, including federal court) I have discovered from official documents that parliamentary oversight on the federal and cantonal levels has been abandoned and replaced by the ideology of separation of power. The result was a general form of corruption amongst state offices<sup>3</sup> which is statistically documented and can (or could) be confirmed by lawyers, but they live too well from it to do so. For this reason, especially in the canton of St. Gallen, the legislation for the municipal Control Committees (CC) was changed<sup>4</sup> so that, for decades, all the municipal assembly receives is a meaningless report. The CC keeps what actually hap-

pened to itself, under threat of disciplinary and criminal penalties. Although I have not investigated this in every canton, the principle is always the same everywhere. This is one of the fundamentals of criminality amongst authorities on the municipal level. Most of you are probably aware of this problem.

With this in mind, one would have to be able to understand how authority<sup>5</sup> is exercised, because we are never taught about that. Even our governments do not know how authority is exercised, because they are told what to do and what not to. It is important to learn this, because once we understand this mechanism, we will be able to take our destinies into our own hands, instead of being bullied and exploited by others.

Once one has understood this, one begins to ask who organised it all. Then one always gets the same answer, which does not fit into the conditioned view of the world. But if one takes the trouble to take a deep look into this, one will note that the history<sup>6</sup> (or, rather, fragments thereof) which we learn in school does not correlate to the facts, and moreover, the course of history is by no means the result of chance. Action and reaction are planned far in advance, thus pushing humanity in a single direction.

Working through history since the French Revolution and gaining an initial understanding of it is relatively easy. However, history before the French Revolution, to say nothing of ancient history, is much more difficult, especially when it comes to philosophy (*recte philosophia*). In order to understand these connections, one must have the privilege of having been introduced to the old natural science, which once was universally widespread: the Teachings of the Three Worlds<sup>7</sup>. Moreover, one must have the will to learn them, which is not easy, otherwise one has no chance of understanding the connections. But these very teachings have been systematically demolished for millennia and replaced with present-day academic knowledge, with its axioms and ideologies. Once one understands these teachings and the authoritarian means of control, one will also understand the motives behind them. However, you cannot study these teachings right away, since you would need far too long to understand them. Concentrate on the major connections.

The cause of these events goes all the way back to Babylon, which is why I refer to their representatives or organisations as being Babylonian.

If you have gained an initial overview of this, then you do understand a few things, albeit not much yet, since it is now essential for you to process how our monetary system works and the main problems with it (money as debt, money creation, and interest). Above all, it must be explained why we cannot create our own money. This knowledge is essential in the present day, since money can buy anything – even court rulings. This is even stated in Art. 18 of the Cantonal Constitution of Zürich (*wohlfeil* = easily available for purchase). What is going on with the monetary system is a tremendous deception of humanity, but no one wants to acknowledge that, let alone correct it.

An even greater deception than that of money is the ideology of human being / person (straw man). A human being is free by nature, but a person is not. The latter is required to do this and that, and they usually obey it all without a word of complaint. This deception begins with the announcement of birth. After that, the civil registry office issues a birth certificate on behalf of the state. This is nothing other than a straw man from which the person of the human being that was born is fabricated. For this reason, he is not described in any law; only cantonal ordinances refer to him, stating that this document has to be presented. The birth certificate is created in the name of the person – the straw man. It is an asset that is traded on the stock market. The state can use these birth certificates in high finance, i.e. in Babylon, to buy loans, for which high interest rates can be charged. In terms of commercial law, a birth certificate is a deed of gift, i.e. the state, as issuer of these certificates, gifts them to Babylon, which

makes it clear that the state cooperates with Babylon. But this is already clear from history, since the nation states were established by Babylon. It is just one little step on the way to Babylon's goal.

This ideology is based on two papal bulls from the 15th century. In the process, the child is firstly separated from any right to property and secondly robbed of the rights to its own body, thus damning it to eternal servitude – as a slave.

With this in mind, one must ask where the word for person comes from in the first place. First appearing in the 13th century, the word is borrowed from the Latin *persona*, denoting the mask of an actor – the straw man. This means that the definition – or ideology – of the person was introduced deliberately, in order to turn human beings firstly into persons, i.e. unfree humans, and then to enslave them.<sup>8, 9, 10, 11</sup>

However, we are far from finished here, since this is where the self-dealing starts<sup>12</sup>. In self-dealing, the same persons act on both sides of the transaction in question: they act as representative on behalf of another party on one side, and make statements on their own behalf on the other, i.e. they conclude a contract with themselves. Self-dealing is thus a claim of a public body (or vicarious agent thereof) towards a legally fictitious person (straw man). However, the latter – the person, the straw man – belongs to the state.

Since the persons with whom the human beings identify are not allowed to own property due to the papal bull and the Babylonian state has organised it to be this way, everything belongs to the state, and the people are only allowed to use it. But if everything belongs to the state, it cannot level any claims against itself. But this is precisely what it does on a constant basis – with taxes, duties, fines and much more, since the construct of the person, the straw man, belongs to it, although the human being does not. Human beings are only made to believe that they are this construct, the person, the straw man. Therein lies the malicious and systematic deception. According to Article 32 of the Swiss Civil Code (CC 210)<sup>13</sup>, anyone who avails himself of a right must prove that a person is alive or dead. But fictional persons in the legal sense (straw men) were never alive.

Therefore, according to the Swiss Criminal Code (CC 311.0)<sup>14</sup>, such self-dealing in principle falls under criminal offences against property, specifically under Art. 158 (Criminal mismanagement) and/or Art. 157 (Profiteering); these are ex officio offences which the state does not prosecute, because it itself is the perpetrator. But you, as municipal and city councils, structure your administrations to do precisely that. As their superiors, this makes you jointly responsible for these crimes.

It now becomes more complicated because, since civil servant status was abolished, authorities and public offices have silently transformed into businesses. By now, they all have an enterprise identification number (UID)<sup>15</sup>, which, since 2014, has also replaced the previous commercial register number. However, the UID alone does not make a company, because this requires an entry in the commercial register. But these very authorities and offices have such an entry, yet it is not made public by the Commercial Register Offices, nor is it published in the Swiss Official Gazette of Commerce (SOGC).

They can only be found through private business information companies<sup>16</sup> in some cases, which makes it clear that an insidious process is underway which must be kept out of public knowledge.

If, as a result of the aforementioned ideology, human beings have no property, it is only logical that these (private) enterprises belong not to them, but to the state, which is why it must bring it under its control – not for itself, of course, since it is deeply indebted to Babylon, its exponents even more so: the parliaments, the governments and the courts stand exclusively in its service. That is the reason why daily life is becoming ever more difficult and freedoms ever more restricted.

This ideology harkens back to the Washington Consensus. It is an economic programme which arose as part of the planned Latin American debt crisis in the 1980s and was facilitated by the International Monetary Fund (IMF) and the World Bank, both Babylonian organisations.

The idea behind the Washington Consensus is that the state should stay out of economics and that the national economies should increasingly be integrated into world trade. This is achieved by applying structural adaptation programmes and the gradual privatisation of state enterprises. But precisely for this purpose, the state-owned enterprises such as the railways, post, telephone system and, in the municipalities, the utilities companies and waterworks were privatised. Then came a second wave of privatisation with the public authorities and offices as companies.

All of these enterprises, which carry out sovereign actions, require legitimation approved by an authorising body in order to do so, otherwise anyone could appropriate the role of police and start collecting fines, for example. But none of these enterprises is able to produce evidence of this legitimation, let alone from an independent authorising body, because no such thing exists. Moreover, all who preside over such undertakings are licenced traders who are actually unauthorised, for applicable law requires them to be publicly published in the Official Gazette of Commerce. Yet to date, this has never been done. This is compounded by the fact that there has never been any official parliamentary ruling on this which has ever been promulgated to the public. Furthermore, neither the haggard parliaments, governments nor courts in the Confederation and cantons are independent, since they demonstrably favour Babylon to the detriment of the people.

With this in mind, I conducted an acid test with the police, since it is a simple matter to provoke them into imposing a fine. The result<sup>17</sup> is that the initial letters are rejected. Only when one takes harder action against the top leadership do the police give up and no more fines are imposed. However, they do not retract the fines, even though they risk having to pay high amounts in claims for damages. This way, the proceedings can be seen as being bilateral and receive no publicity – thus protecting the Babylonian system. In other words, the police in charge are well aware that they, as supposed 'custodians of the law', are doing nothing more than committing banditry and coercion – i.e. criminal acts. These are ex officio offences.

The second wave of privatisation plays an important role in the current COVID-19 pandemic. The virus is merely a means to an end to frighten and enfeeble the people. Moreover, the COVID legislation only applies to persons and not to human beings. This disease is only triggered by frequencies which are boosted by mobile radio without anybody noticing. Healing and diseasing can be done through frequencies – the work of instruments of domination. For that reason, everyone accepts what the unauthorised authorities lead us to believe, but nobody wants to discover the actual reason for. This is a deliberate effort to further fragment and repress society. The actual problem – or aim behind it – is thoroughly concealed in the process. The Babylonian World Economic Forum (WEF) describes the intent behind the corona pandemic on its homepage. But as long as one has no idea of the connections, one will not understand these explanations, if one even comes across them at all. For that reason, I have explained them in my essay on COVID-19 Ideology<sup>18</sup>.

If you have understood everything described above, you should note that you bear a heavy burden, for not only do you commit criminal acts against property, you are neither entitled to take action nor legitimised to carry out sovereign acts. This means that you personally assume full responsibility for all of these crimes. Furthermore, you are being manipulated by the church, politicians, educational system and media.

Parliaments and governments are not willing to put an end to this official criminality, since they only continue to exacerbate it. For that reason I hold the Federal Council and all cantonal governments to account, yet they throw all of that to the wind, for they are of the view that they can simply proceed in this manner indefinitely. The parliaments play hide and seek by deliberately protecting this criminality under the ideological mantel of separation of powers.

For maritime law – the law of piracy, the doctrine of might makes right – prevails on land as well, and I am confident that one day the government will draw the short end of the stick, and I will come out on top. Therefore, I have imposed conditions upon it accordingly, conditions which it will naturally throw to the wind, unless something someday drives the population to take positive action. Among other things, it would be obliged to make all employees of the enterprises (including those of the municipalities) which carry out sovereign acts without legitimation aware of the problematic situation they are in. It has deliberately neglected to do so.

In this business, one must be aware that the representatives of Babylon sit not only in governments and parliaments, but also on municipal and city councils, as well as in the administration. These representatives are preferably (albeit not only) educated in law, since 'law' can be used to subjugate the entire population. These representatives are not addressed, for they operate for secret Babylonian organisations, which is why they can only be recognised by their deeds. For that reason, it is of the utmost importance for people to understand the connections and actually know what is going on.

\* \* \* \* \*

I am aware that everything I have presented above will be quite an affront to you. But you cannot be allowed to go on living in an illusion that is packaged in ideologies. Someday you – or society as a whole – will finally have to face the truth and take the responsibility for your lives into your own hands.

Since it is my professed intent to clean up this criminal Babylonian system, I have to hold you, as municipal and city councils, to account. Based on the aforementioned framework, it would create the circumstances for the municipal and city councils to cast away their Babylonian muzzle by informing the municipal assembly and/or parliament of actual incidents that are going on, instead of just omissions, half-truths or falsehoods. However, this can only be done if one has a clean record, which is not easy under the current regime, especially if one is not well-versed in business matters. This would make it possible to cast off the Babylonian yoke, avoid a potential civil war and bring the culprits to justice.

In order to put an end to these criminal Babylonian activities, I see no other choice but to resort to maritime law.

If the municipal or city council does not state the plain facts in its reports to the municipal assembly or parliament starting in January 2021, every member of the council will be subject to the requirement of having to pay every member of the community entitled to vote a fee of 100 grams of gold<sup>19</sup>. For the sake of simplicity, this fee is to be collected from the enterprise of the municipality or city. The respective owners of the enterprise in question will collect the claims collectively from the municipal/city councils belonging to Babylon. But all councils which refrain from signing such a useless report and pose an alternative view instead will not be punished. However, they must clearly and publicly distance themselves from the very outset. This is intended to separate the wheat from the chaff. Furthermore, it must be noted that, in addition to the government, such a fine shall be imposed upon the public

prosecutor's office as well.<sup>20</sup> The latter will thus have to be wary of taking action, lest it suffer the same fate. With the entire state prosecution laid low, the political class will have no choice but to finally put an end to this criminality.

Therefore, the municipal or city council also has the duty of immediately notifying all employees that they are henceforth acting at their own risk under penalty of civil and criminal action. The same general conditions<sup>20</sup>, which every subject can demand from the responsible parties or actors (or the enterprise of the municipality or city), apply here as well.

This course of action is entirely legal and is based on laws and conventions which have already been enacted. The only thing unusual about it is that the system is reversed, because you never even took the time to think about its very existence. At the same time, one need not fear that the system would collapse, because it is not the task of human beings who want to be free to preserve a system which ruins their lives. 'Thanks' to the human being/person ideology, human beings are penniless anyway. Therefore the Babylonian state – i.e. Babylon – must take the responsibility for it. However, Babylon is not (yet) prepared for the scenario described above. So if we join forces, we could shut it down so that humanity could take command of itself. But this must happen immediately, otherwise Babylon will take countermeasures.

What are you still waiting for? There will never be a better opportunity. Get to it at last! Study history, learn how money and domination work, learn facts and truths instead of ideologies! But above all, it is urgent that you spread this realisation to those around you (instead of contacting me) and call on them to do the same, since this is the only way to cast off the Babylonian yoke.

If society can still develop a will of its own, it will be possible to get rid of all governments in Switzerland inside of three weeks. After that, a provisional government will have to be elected to replace them. It will immediately be necessary to appoint new parliaments under a new electoral code, since the universal Babylonian parties make sure that only their Babylonian brothers and sisters have a place there. All that came before and all Babylonians will have to be replaced, and the Babylonians will have to be removed from all public offices. If this is to be achieved, cantonal elections can be held in three months; in the federal government it will take a bit longer. But the WILL to do so must be there!

Send all of the politicians and members of Babylonian organisations off into the 'desert' from whence this all arose, and send them a hefty bill. Only once this has been pushed through rigorously can something new, something positive for humanity, be established.
